Market Summary

The stock market on Thursday remained negative in majority part of the day and concluded the session in the red zone amid investors engaged in selling activities, leading to a brief period of correction in the market. The Benchmark KSE-100 index made an intra-day high and low at 71,292.83 (190.29 points) and 70,562.12 (-540.42) respectively while closed at 70,657.64 by losing 444.90 points. PKR in today's interbank appreciated by Rs 0.0142 against USD and closed at Rs 278.3000. The value of shares traded during the day was Rs19.022 billion. Market capitalization stood at around Rs9.655 trillion. Overall, trading volumes for the day decreased to 436.81 million shares compared with Tuesday's tally of 560.29 million. KEL was the volume leader with 30.1 million shares, losing Rs0.21 to close at Rs4.23. It was followed by WTL with 25.1 million shares, losing Rs0.02 to close at Rs1.26 and BOP with 20.2 million shares, losing Rs0.2 to close at Rs4.90

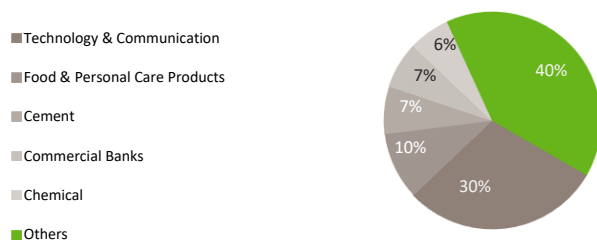

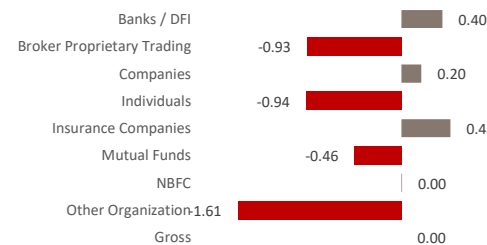

Overall Sector Turnover (%)

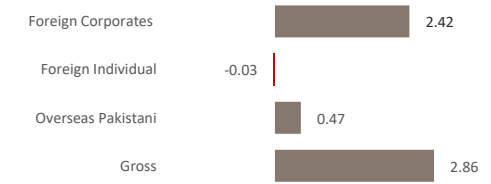

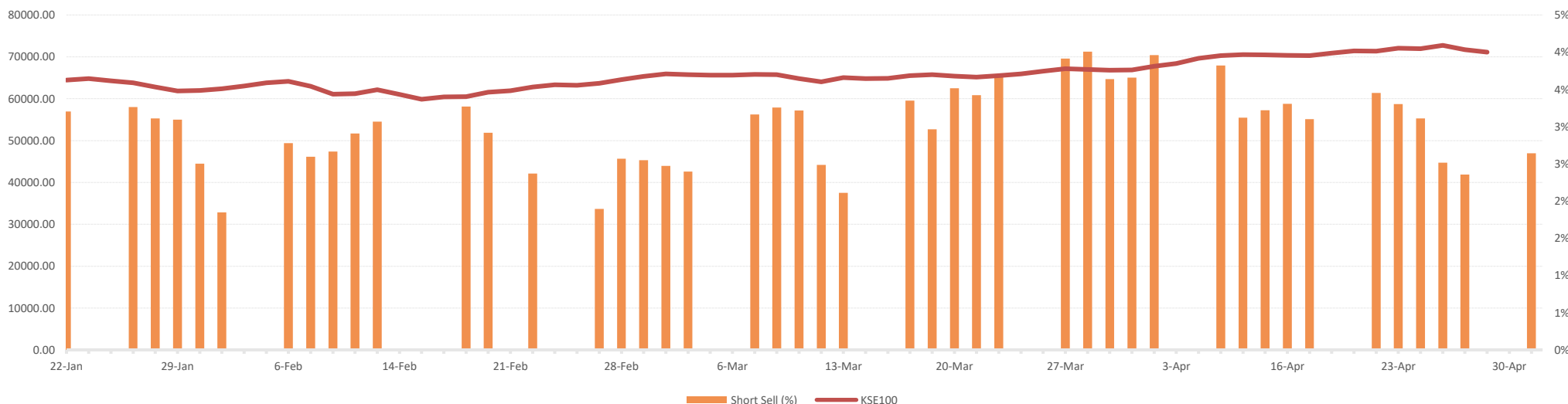
