## Market Summary

The stock market on Wednesday remained negative throughout the day and concluded the session in the red zone amid profit taking by the investors ahead of fiscal year budget. The Benchmark KSE-100 index made an intra-day high and low at 74,758.11 (91.46 points) and 74,136.52 (-530.13) respectively while closed at 74,219.43 by losing 447.22 points. PKR in today's interbank depreciated by Rs 0.0043 against USD and closed at Rs 278.3000. The value of shares traded during the day was Rs16.384 billion. Market capitalization stood at around Rs10.005 trillion. Overall, trading volumes for the day decreased to 348.45 million shares compared with Tuesday's tally of 414.15 million. KEL was the volume leader with 25.3 million shares, losing Rs0.01 to close at Rs4.86. It was followed by AMTEXDEF with 23.6 million shares, gaining Rs1 to close at Rs3.56 and WTL with 16.1 million shares, losing Rs0.02 to close at Rs1.32

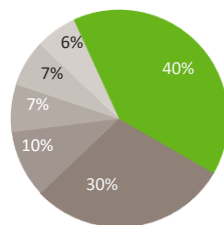

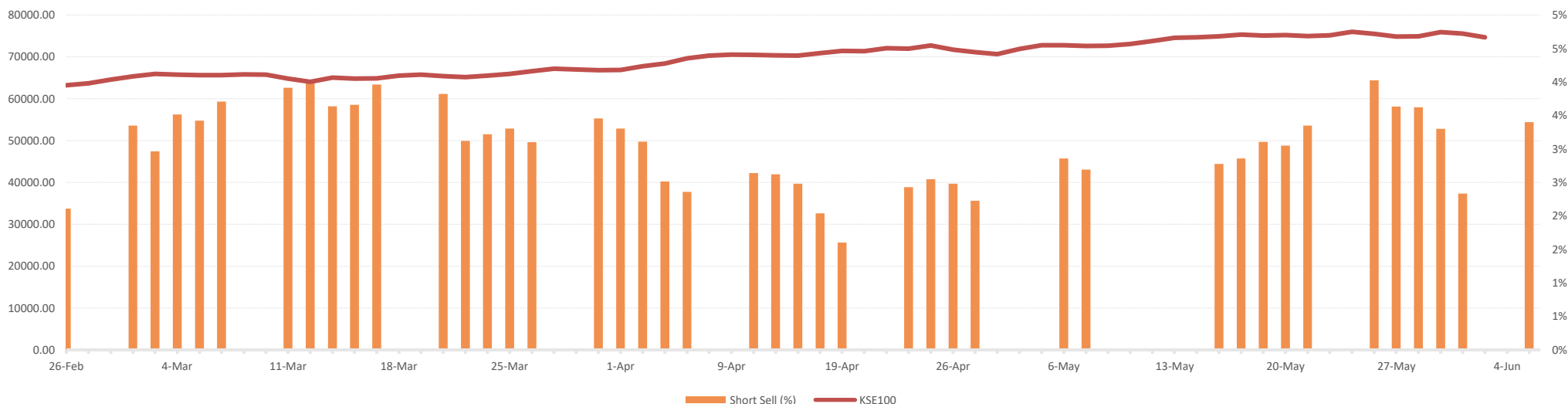
