

Market Summary

The stock market on Thursday remained extremely bullish throughout the day and concluded the session above the 114,000 level, marking a new all-time high amid robust economic indicators and expectations for a significant interest rate cut in the MPC meeting coupled with recovery in global equities. The Benchmark KSE-100 index made an intra-day high and low at 114,408.62 (3,598.41 points) and 111,308.65 (498.44 points) respectively while closed at 114,180.50 by gaining 3,370.29 points. PKR in today's interbank depreciated by Rs 0.0623 against USD and closed at Rs278.2305. The value of shares traded during the day was Rs67.198 billion. Market capitalization stood at around Rs14.515 trillion. Overall, trading volumes for the day increased to 1.464 million shares compared with Wednesday's tally of 1.079 million. WTL was the volume leader with 232.9 million shares, gaining Rs0.14 to close at Rs1.79. It was followed by CNERGY with 80.2 million shares, gaining Rs0.1 to close at Rs7.21 and PIBTL with 70.7 million shares, gaining Rs1 to close at Rs9.




