






## **Market Summary**

The stock market on Thursday remained under immense selling pressure throughout the day and concluded the session deep in the losses amid massive profit taking by the investors coupled with decline in global indices. The Benchmark KSE-100 index made an intra-day high and low at 111,745.02 (674.73 points) and 105,937.37 (-5,132.92 points) respectively while closed at 106,274.97 by losing 4,795.32 points. PKR in today's interbank depreciated by Rs 0.125 against USD and closed at Rs278.3500. The value of shares traded during the day was Rs56.61 billion. Market capitalization stood at around Rs13.601 trillion. Overall, trading volumes for the day increased to 1.155 million shares compared with Wednesday's tally of 1.107 million. WTL was the volume leader with 177.6 million shares, losing Rs0.19 to close at Rs1.52. It was followed by KEL with 81.9 million shares, losing Rs0.39 to close at Rs5.22 and CNERGY with 68.3 million shares, losing Rs0.7 to close at Rs5.84.


