Market Summary

The stock market on Thursday opened on a bullish note following the Eid ul Adha holidays, gained 2,094 points in a single day, and concluded the session in the green zone amid optimism prevailing among the investors. The Benchmark KSE-100 index made an intra-day high and low at 78,890.37 (2,183.60 points) and 76,896.81 (190.04) respectively while closed at 78,801.53 by gaining 2,094.76 points. PKR in today's interbank depreciated by Rs 0.0903 against USD and closed at Rs 278.6000. The value of shares traded during the day was Rs20.668 billion. Market capitalization stood at around Rs10.420 trillion. Overall, trading volumes for the day increased to 452.29 million shares compared with Friday's tally of 394.91 million. SILK was the volume leader with 53.6 million shares, gaining Rs0.23 to close at Rs1.09. It was followed by KEL with 23.1 million shares, gaining Rs0.1 to close at Rs4.72 and HBL with 20.9 million shares, gaining Rs9.55 to close at Rs121.92.

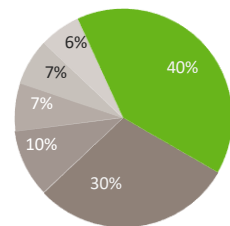

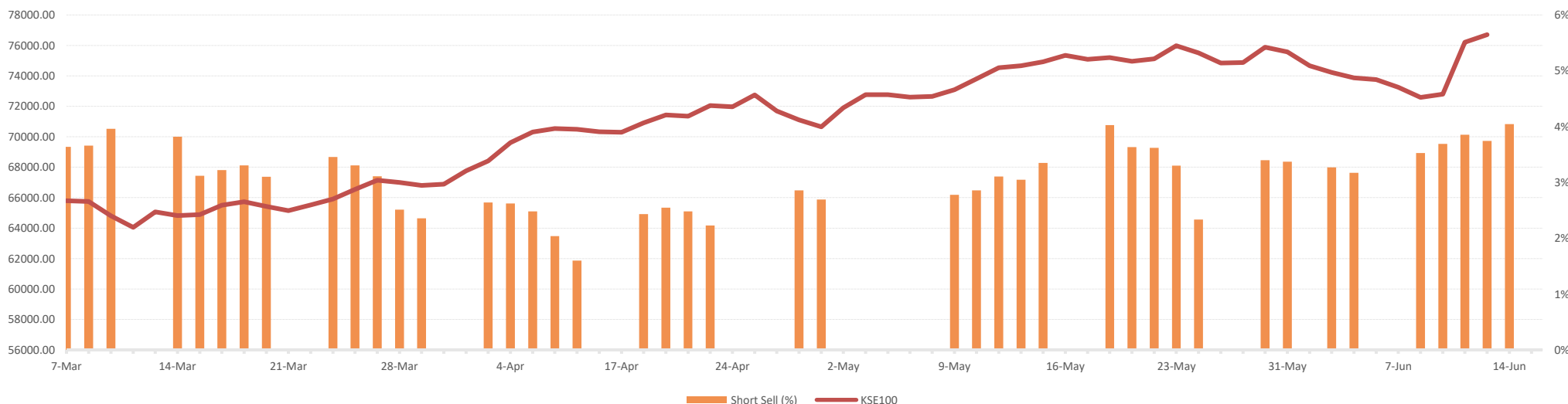
