Market Summary

The stock market on Tuesday opened on a bullish note and concluded the session in the green zone as investors rejoice after the International Monetary Fund's (IMF) Executive Board on Monday approved the disbursement of \$1.2 billion for Pakistan under the Extended Fund Facility (EFF) and the Resilience and Sustainability Facility (RSF). The Benchmark KSE-100 index made an intra-day high and low at 169,601.03 (1,297.79 points) and 168,880.21 (576.97 points) respectively while closed at 169,456.38 by gaining 1,153.14 points. PKR in today's interbank appreciated by Rs 0.0086 against USD and closed at Rs 280.4135. The value of shares traded during the day was Rs 51.187 billion. Market capitalization stood at around Rs19.267 trillion. Overall, trading volumes for the day increased to 1022.50 million shares compared with Monday's tally of 781.35 million. KEL was the volume leader with 86.7 million shares, gaining Rs0.19 to close at Rs5.74. It was followed by BNL with 62.1 million shares, gaining Rs0.07 to close at Rs14.22 and PIAHCLA with 41.2 million shares, gaining Rs3.6 to close at Rs47.63.

Overall Sector Turnover (%)




