### Market Summary

The stock market on Monday plunged nearly 8,700 points in the first half. However, it recovered half of its earlier losses in the second half and concluded the session in the red zone amid selling comes on account of US President Donald Trump's reciprocal tariffs, further fueling fears of a global economic slowdown. The Benchmark KSE-100 index made an intra-day high and low at 117,601.62 (-1,190.04 points) and 110,103.97 (8,687.69 points) respectively while closed at 114,909.48 by losing 3,882.18 points. PKR in today's interbank depreciated by Rs 0.1029 against USD and closed at Rs280.5688. The value of shares traded during the day was Rs42.427 billion. Market capitalization stood at around Rs13.999 trillion. Overall, trading volumes for the day increased to 702.59 million shares compared with Friday's tally of 447.08 million. WTL was the volume leader with 55.3 million shares, losing Rs0.07 to close at Rs1.28. It was followed by CENERGY with 53.4 million shares, losing Rs0.46 to close at Rs7.83 and BOPXD with 34.2 million shares, losing Rs0.62 to close at Rs10.39.

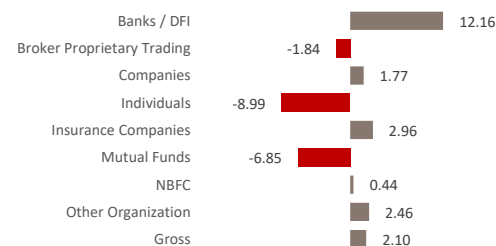

#### Overall Sector Turnover (%)

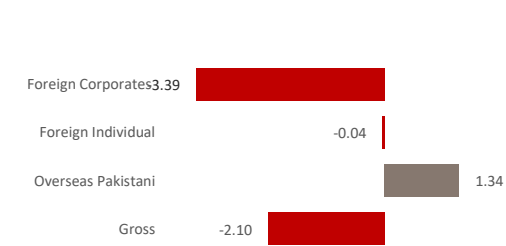

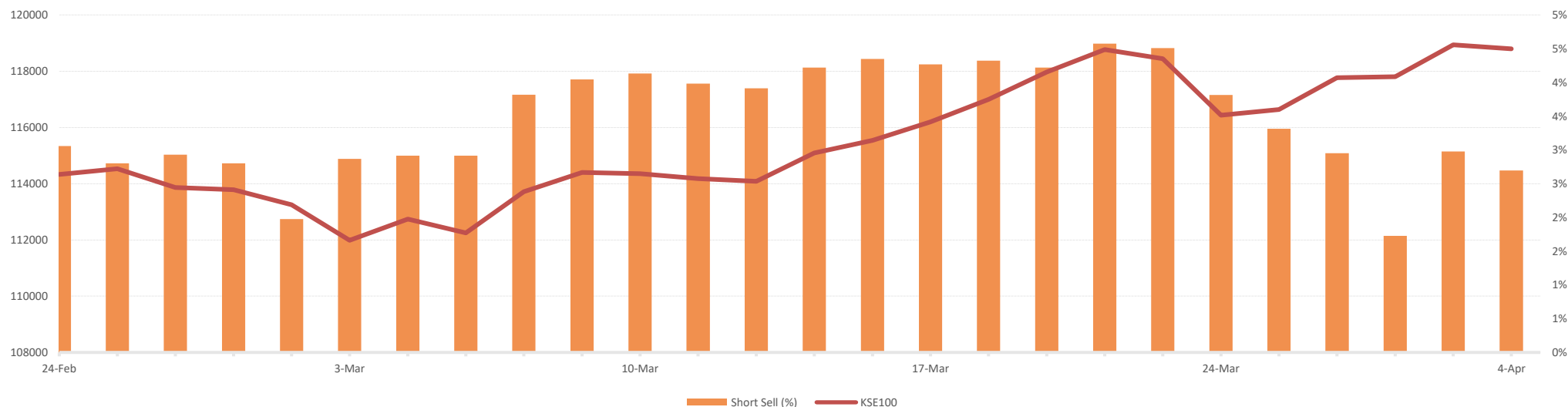
