Market Summary

The stock market on Tuesday remained volatile in opening hours and concluded the session in the green zone as strong corporate results boosted confidence, coupled with inflow of overseas remittances into Pakistan stood at \$3.1 billion in August 2025. The Benchmark KSE-100 index made an intra-day high and low at 157,088.80 (1,001.50 points) and 155,044.25 (-1,043.05 points) respectively while closed at 156,563.52 by gaining 476.22 points. PKR in today's interbank appreciated by Rs 0.0095 against USD and closed at Rs281.6133. The value of shares traded during the day was Rs 55.157 billion. Market capitalization stood at around Rs18.292 trillion. Overall, trading volumes for the day decreased to 1066.57 million shares compared with Monday tally of 1123.59 million. KEL was the volume leader with 169.6 million shares, gaining Rs0.13 to close at Rs5.75. It was followed by BOP with 83.9 million shares, gaining Rs0.01 to close at Rs19.66 and WTL with 74.1 million shares, gaining Rs0.09 to close at Rs1.52.

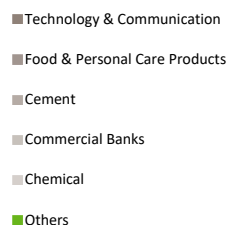

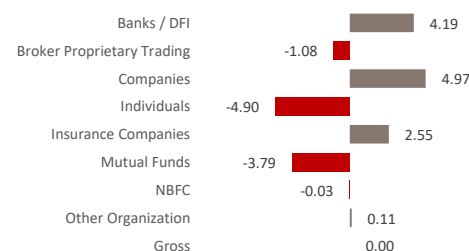

Overall Sector Turnover (%)

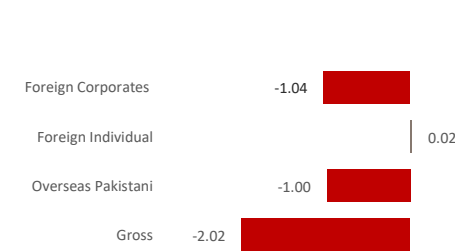

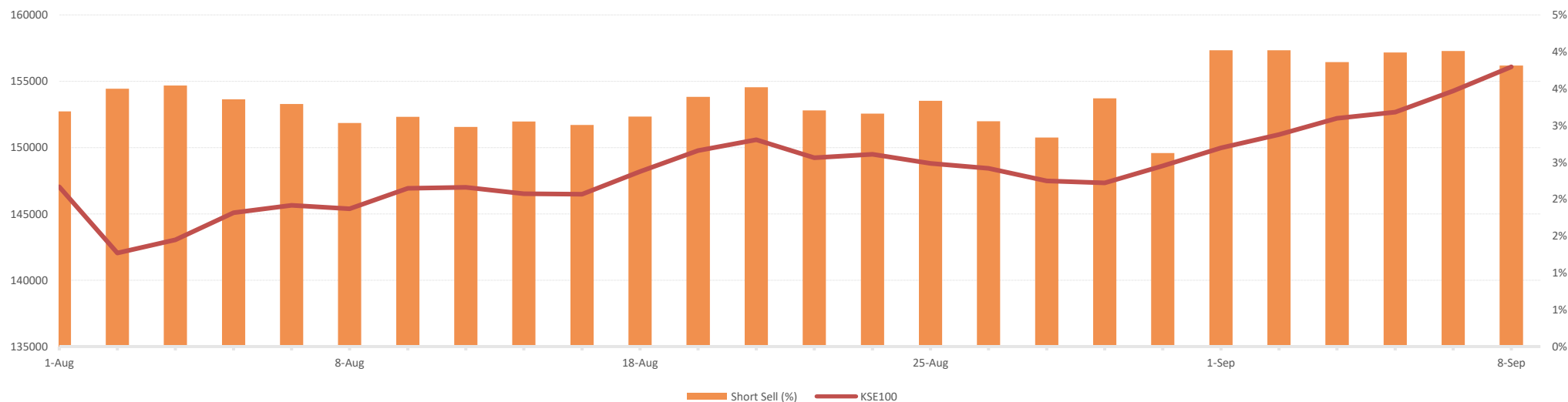
