


Market Summary

The stock market on Wednesday remained negative in majority part of the day and concluded the session in the red zone amid uncertainty prevailing among investors regarding the ongoing IMF review. The Benchmark KSE-100 index made an intra-day high and low at 114,661.88 (484.23 points) and 114,001.50 (-176.15 points) respectively while closed at 114,084.53 by losing 93.15 points. PKR in today's interbank depreciated by Rs 0.0185 against USD and closed at Rs279.9728. The value of shares traded during the day was Rs20.233 billion. Market capitalization stood at around Rs14.047 trillion. Overall, trading volumes for the day decreased to 298.75 million shares compared with Tuesday's tally of 318.24 million. SSGC was the volume leader with 18.3 million shares, losing Rs0.19 to close at Rs36.84. It was followed by PREMA with 14.9 million shares, gaining Rs3.54 to close at Rs38.91 and BOP with 14.4 million shares, losing Rs0.07 to close at Rs13.09.


Overall Sector Turnover (%)
