Market Summary

The stock market on Thursday opened on a positive note. However, all of its earlier gains were erased in the second half and concluded the session in the red zone amid investors engaged in profit taking activity. The Benchmark KSE-100 index made an intra-day high and low at 121,745.30 (1,279.37 points) and 119,770.03 (-695.90 points) respectively while closed at 120,002.59 by losing 463.34 points. PKR in today's interbank depreciated by Rs 0.0877 against USD and closed at Rs283.6416. The value of shares traded during the day was Rs20.350 billion. Market capitalization stood at around Rs14.521 trillion. Overall, trading volumes for the day decreased to 598.078 million shares compared with Wednesday tally of 703.65 million. WTL was the volume leader with 64.6 million shares, losing Rs0.01 to close at Rs1.49. It was followed by SSGC with 35.6 million shares, losing Rs0.96 to close at Rs43.28 and PMI with 30.3 million shares, losing Rs0.3 to close at Rs4.31.




