Market Summary

The stock market on Monday remained volatile throughout the day and concluded the session in the green zone amid investor's sentiment remained subdued. The Benchmark KSE-100 index made an intra-day high and low at 120,285.54 (636.40 points) and 119,250.67 (-398.47 points) respectively while closed at 119,689.63 by gaining 40.49 points. PKR in today's interbank depreciated by Rs 0.1042 against USD and closed at Rs281.7688. The value of shares traded during the day was Rs22.258 billion. Market capitalization stood at around Rs14.389 trillion. Overall, trading volumes for the day decreased to 424.23 million shares compared with Friday's tally of 570.29 million. FFL was the volume leader with 60.6 million shares, gaining Rs1.11 to close at Rs16.28. It was followed by CSIL with 20.1 million shares, gaining Rs0.13 to close at Rs3.15 and PREMA with 18.3 million shares, losing Rs3.7 to close at Rs46.13.

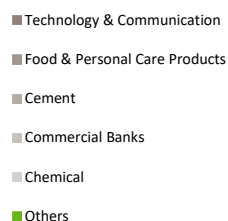

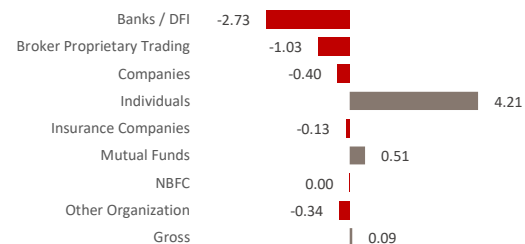

Overall Sector Turnover (%)

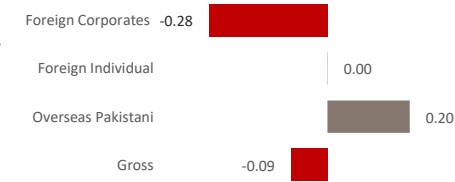

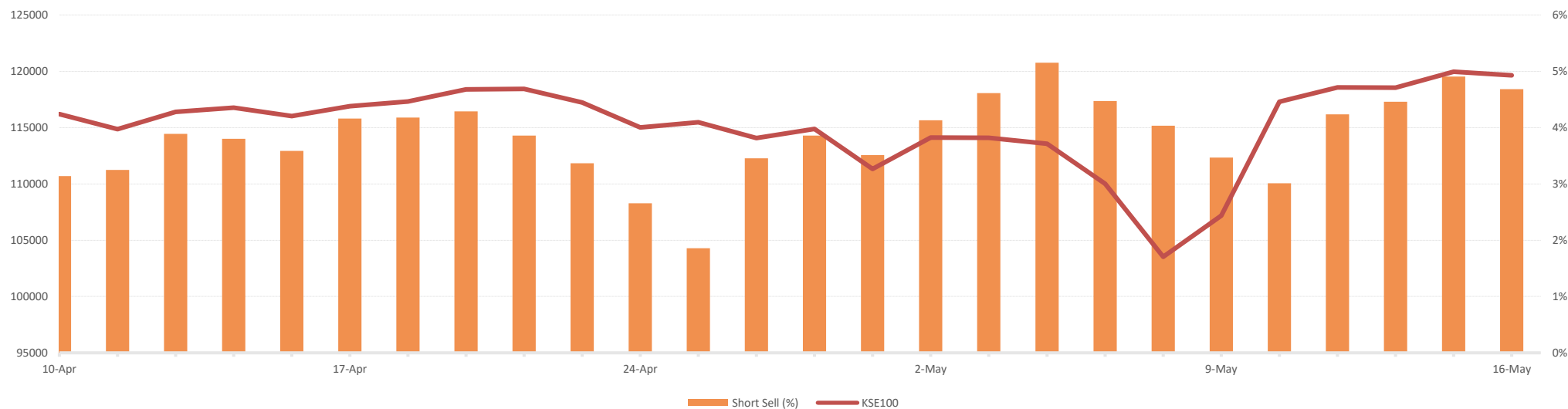
