## Market Summary

The stock market on Tuesday remained volatile throughout the day and concluded the session in the green zone amid investor's sentiment remained subdued. The Benchmark KSE-100 index made an intra-day high and low at 118,807.92 (586.80 points) and 118,143.67 (-77.45 points) respectively while closed at 118,332.90 by gaining 111.78 points. PKR in today's interbank depreciated by Rs 0.116 against USD and closed at Rs282.1728. The value of shares traded during the day was Rs23.817 billion. Market capitalization stood at around Rs14.345 trillion. Overall, trading volumes for the day increased to 689.63 million shares compared with Monday's tally of 634.25 million. KEL was the volume leader with 267.6 million shares, gaining Rs0.17 to close at Rs5.89. It was followed by WTL with 31.6 million shares, gaining Rs0.03 to close at Rs1.3 and PTC with 20 million shares, gaining Rs0.21 to close at Rs24.28.

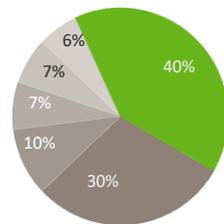

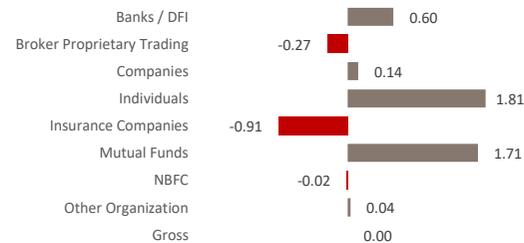
### Overall Sector Turnover (%)
