Market Summary

The stock market on Thursday remained positive in the first half of the day. However, some of earlier gains were eroded in the second half and concluded the session in the green zone amid positive sentiments prevailing among the investors. The Benchmark KSE-100 index made an intra-day high and low at 119,639.47 (1,306.57 points) and 118,481.97 (149.07 points) respectively while closed at 118,971.40 by gaining 638.50 points. PKR in today's interbank appreciated by Rs 0.104 against USD and closed at Rs282.0688. The value of shares traded during the day was Rs23.899 billion. Market capitalization stood at around Rs14.424 trillion. Overall, trading volumes for the day increased to 740.98 million shares compared with Tuesday's tally of 689.63 million. WTL was the volume leader with 137.5 million shares, gaining Rs0.13 to close at Rs1.43. It was followed by KEL with 119.6 million shares, losing Rs0.37 to close at Rs5.52 and PTC with 65.7 million shares, gaining Rs1.95 to close at Rs26.23.




Overall Sector Turnover (%)


